**\*Old Bylaw # / Policy: Article IV Section 4.10 Director of Coaches**

**\*Original Text:** The Director of Coaching shall:

1. Coordinates and oversees the soccer training.
2. Assigns team coaches prior to seasonal tryouts.
3. With the approval of the BOD, hire, supervise and maintain a qualified professional training staff to meet the needs of the competitive players as per the budget.
4. Organize and oversee annual tryouts.
5. Coordinate practice and game schedules with the Commissioner of Recreational.
6. Provide timely notification of available coach licensing courses, tournaments etc. to competitive coaches.
7. Oversee and communicate OYSA's policies as it relates to sportsmanship and acceptable behavior when engaged in games or practices.
8. In the event that the Director of Coaches (DOC) position is unfilled, Article IV, Sections 4.10.1 through 4.10.7 shall revert to the General Manager as Article IV, Sections 4.09.17 through 4.09.23 or consecutive numbering following the last used section of Article IV, Section 4.09.
